- All entries must read and agree to the Parade Entry Acknowledgment form

There is one Santa already in the parade. To reduce the confusion for children and to keep the spirit of Christmas, additional Santas will not be allowed to participate in the parade. This will be enforced when checking in at the registration table.

#### PARADE ENTRY ACKNOWLEDGMENT

As a participant in the Vernal Area Chamber of Commerce Parade of Lights parade to be held on Friday, November 24th, 2023, I hereby understand and agree to comply with the following terms and conditions of the parade application/contract. Any negligence on my part to comply with this application/contract will cause my entry to be disallowed at the time the application is submitted, or the day of the event:

- All participants agree to abide by all requirements imposed by the Vernal Area Chamber of Commerce for this parade
- The Vernal Area Chamber of Commerce requires that all entries be **decorated and relate to the chosen theme.** This year's theme is "Holly Jolly Christmas". Entries should relate to the theme and be decorated including business entries, trucks, vehicles, cars, flatbed trailers, and other entries.
- All entries must have a detailed description of what the float or entry will be in order to ensure that the float description
  reflects an accurate description of the actual float as well as to provide a description for the announcer to announce your
  entry.
- No Changes to your Entry: Your parade entry must arrive at the parade route as it is described on your entry form. No changes are permitted to your entry after the entry deadline. For example, if you describe your group as "walkers and no vehicle," then you are not permitted to add a vehicle after the registration deadline. Any unauthorized changes or additions (including the addition of vehicles) to your entry may cause other arrangements, including disqualification, of your unit at the time of the Parade. All decisions are at the discretion of the Vernal Area Chamber of Commerce and are FINAL.
- All parade participants agree not to distribute or display any obscene material or materials harmful to minors during the course of the parade.
- All participants agree that NO items, including candy, will be thrown or distributed from the float, vehicle, or any
  other type of entry in the parade. Walking along the edge of the street and handing candy or other materials directly to an
  individual IS permitted.
- Parade entries are NOT allowed to encourage spectators to enter the street.
- All parade participants will clean up any litter or debris, including manure, created by their entry, at the staging area, during the parade, and at the disassembling area of the parade.
- All participants agree that the maximum speed for any vehicle, bike, motorcycle, ATV, or other vehicle is 15 mph in the
  parade.
- All parade participants understand that getting on and off the float/trailer will NOT be permitted during the parade
- All parade participants shall conduct themselves in a safe and courteous manner just before, during the course of the parade, and in the disassembling area.
- The Vernal Area Chamber of Commerce Parade of Lights is a **family-friendly event** for all ages with young children present, and every entry in the parade is expected to respect this. Failure to comply may result in being asked to leave the parade immediately with no warning and may jeopardize a group's approval to participate in the following years. All decisions are at the discretion of the Vernal Area Chamber of Commerce and are final.

- All costumes, outfits, behavior, attitude, language, and dance moves **must be appropriate for a young audience** and reflect a family-friendly event, and will be held to a high standard.
- The Vernal Area Chamber of Commerce reserves the right to disallow any lewd behavior, anything promoting violence of any kind, pornography, hate speech of any kind, or any criminal acts upheld by the State of Utah.
- Music or bands may play for entertainment purposes while riding on a float or marching in the parade but must always
  maintain forward progression. Performers must be able to always maintain forward progression.
- Your entry will be provided with a number card that must be visible and clearly displayed on the **RIGHT SIDE** (the passenger side) of the parade route in order for the judges to identify your group.
- Each entry must provide at least one adult supervisor to walk or ride the parade route with the entry.
- No unit, float, or vehicle, may make aggressive, abrupt or rapid movements at any point during the parade route.

  Demonstrations of maneuverability, horsepower, speed agility, etc. is not permitted, including law enforcement motorcycles, go-carts, modified trucks, race cars, etc. Burnouts, wheelies, and donuts are strictly prohibited.
- The use of iPods, MP3 players, cell phones, camcorders, etc. is prohibited by all drivers during the parade.
- All parade entries will submit to the parade sponsor, the Vernal Area Chamber of Commerce, a signed acknowledgment (as
  provided by the Vernal Area Chamber of Commerce and the City) acknowledging that their entry will comply with all
  parade conditions and requirements as imposed by the Vernal Area Chamber of Commerce and Vernal City.

I have read the above conditions and agree to be in full compliance for the parade which I am entered into as described in this acknowledgment. Failure to adhere to these guidelines may result in my entry being expelled from the parade and possible suspension from future participation.
